# Youth statute

This youth statute is to read as § 4 of statute of Pferdesportvereins Ludwigshafen/Rhein e.V. .

### § 1

## name and membership

Name: "Jugend des Pferdesportverein Ludwigshafen/Rhein e.V." (Youth of Pferdesportverein Ludwigshafen/Rhein e.V.).

All young members of Pferdesportverein Ludwigshafen/Rhein e.V. are members elected or appointed by persons within the youth category.

#### § 2

#### tasks

The youth organization is managing itself within these regulations. The tasks of the youth organization are:

- a) support of sport as a main interest of work with young people ( KJHG §11 (3) )
- b) cultivation of continuing in sports to improve body fitness, health and joy of life
- education to critical argumentation with the situation of young people in modern society and mediation of competence of understanding in social connections
- d) development of new forms of sport, training and modern forms of society
- e) cooperation with all youth organizations

f) cultivation of international agreement.

## § 3

# management

The management of the youth of the club is:

- 1. the youth annual meeting of all young members
- 2. the youth committee .

# § 4

# youth annual meeting of all young members

Once a year, normally one month before the AGM of Pferdesportverein Ludwigshafen/Rhein e.V., the youth committee invites all members under 18 years of age to the youth annual meeting of all young members. All young members between 7 and 18 years of age are allowed to vote. Also allowed to vote are: all coaches, who are training young people, and the youth chairman and his deputy.

Tasks of the youth annual meeting are:

- a) election of the youth chairman and his deputy for a period of three years. Both persons have to be 18 years old or older.
- b) election of a youth speaker and his deputy for a period of three years. Both persons have to be under 18 years of age.
- c) changes to the youth statute.
- d) to decide main points of interest of youth work.
- e) suggestion for the program of the year.
- f) passing of youth budget.

The youth chairman or his deputy runs the youth annual meeting. The youth annual meeting is able to take any decisions, if invitation has be given in writing 3 weeks prior the meeting take place. The youth annual meeting is no longer able to take any decisions, if half of the participants will be no longer present. Assumption for that is, that the chairman has noticed before the ability for taking decisions because of an application. For votes and elections a majority of votes of the present young members is enough. Every member of the youth organization has one non transferable vote.

# § 5

# youth committee

The youth committee consists of:

- a) youth chairman
- b) deputy chairman
- c) youth speaker or deputy
- d) coaches of young people.

If necessary more persons can be invited in addition to youth committee meetings for specific items of discussion.

The youth committee has to do the youth work in the club and decides the tasks given from the youth annual meeting.

The youth chairman runs the meetings. He is representing the youth in the club in meetings of the managing committee of the club with right to be invited to the meeting and right to vote.

Tasks of vouth committee are:

- a) care of young members anywhere.
- b) coordination of all youth work.
- c) cultivation of community and support of youth get-together.
- d) making direct contact to parents of young members, to other clubs, to non-local sport associations and to organizations of public and independent youth support.
- e) planing and realizing of the program for the year.
- f) invitation to youth annual meeting.

The youth committee fulfills all tasks within statute of the club, the youth statute and the decisions of youth annual meeting. The youth committee is responsible for all decisions taken to youth annual meeting and to the managing committee of the club.

The youth committee decides the youth budget. At the end of the year a financal report is necessary. The youth chairman has to report to the managing committee of the club about all activities in writing.

# § 6

#### relation to the club

The youth committee can make an application to take measures in the sense of club statute to the managing committee of the club, when offenses, especially against the interests of the club, of young members occur.

# § 7

# final regulation

Changes of this statute must to be decided by the annual meeting of young members. The changed statute is to be given to the AGM for agreement.

If the youth statute has no regulation to specific points, the regulations of the club statute apply.
